Vendor shall list Clifton Springs Area YMCA as an additional insured by endorsement, **acceptable additional insured forms are CG 20 10 or similar**, subject to review. Operator shall obtain Liquor Legal Liability Coverages in amount of minimum limits of \$1,000,000 per occurrence, and shall include Clifton Springs Area YMCA as an additional insured, subject to review.

As a vendor, I agree to the rules and regulations of the event. I agree that the YMCA of Clifton Spring will not be held responsible for any theft, loss of property or personal injury suffered during or as a result of participating in the Sulphur Springs Festival.

## Rules & Regulations

- Vendors are responsible for collecting all necessary sales tax, etc. as required by New York State and Ontario County.
- No vehicles other than food trucks shall be parked in John Brown Park.
- The YMCA Sulphur Springs committee will not be able to provide, tables, ice, etc. You will need to bring any such items you will need.
- Set up time will be 12pm-4pm on Friday and 8am-11am Saturday.
- Tear down time begins at 9pm. Space must be left as you found it. Place trash into designated receptacles or take it with you. All empty containers, boxes, etc. MUST be removed by you.
- You are expected to participate during the festival hours.
- Each vendor is responsible for obtaining and submitting an appropriate Certificate of Insurance and Ontario County Health Permit required for participation.
- You agree to not hold the YMCA of Clifton Springs, landowners of property, the Village of Clifton Springs or event volunteers liable for any injury, damages or losses sustained for the duration of the event, including set up and tear down or as a result of participating in the event.
- Actions deemed inappropriate will not be tolerated.
- Set up in the space designated by the festival committee and understand that pets, firearms, illegal drugs or articles during the festival are prohibited.
- Any and all requirements regarding electricity must be arranged by May 10, 2023.
- Food vendors are prohibited from selling alcohol.
